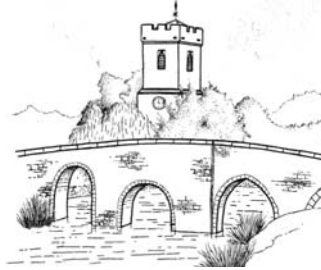


# **BIDFORD ON AVON PARISH COUNCIL**

The reason for the appeal is that SDC, as the Local Planning Authority, is of the opinion that the original application has expired. The original application was received in January 1991 and determined in December 1995 – that is 22 years ago.

If Council wishes to make a representation, this has to be sent by 19<sup>th</sup> April. The Clerk's recommendation, after consulting with the Planning Officer was that, after such a long time and with only one current Councillor involved in the original application, it would not be possible for Council to make a considered decision.
